Discussion and Possible Action Re: Dispatch Radio Console

John Scheper with GTSI explains what GTSI can offer in reference to our dispatch radio console. The payment which is currently being made will stay the same. GTSi is ready to take a \$2,500 cut to make the deal. Some benefits are as follows:

- It is a companion to the system we already have.
- It can have it upgraded as needed.
- Expandability
- Able to integrate with existing call handling system
- Having a back-up in place so we would be able to dispatch our resources more efficiently from other sites, if needed.
- It is more user-friendly.
- Able to use on multiple towers.
- We will be able to use it in the foreseeable future.

This is a system Macoupin County is currently using. If for some reason we were done, Macoupin could seamlessly operate from another site. There is infinite expandability, no single point of failure and no redundancy.

Medora is complete, but needs to be tested. It's not hooked up yet, although it is ready to implement.

Don Little suggests and asks ~ can maybe the ETSB / Sheriff / other public safety entities form a plan and figure out what needs to be done and how to pay for it? Put a game plan in place and then proceed from there. Plan on getting the costs/figures together and have it be a part of next year's budget.

Mike M. asked each member present for their thoughts, which are as follows:

- Mike S. all for going forward.
- Heidi we need a back-up system, however, the cost is scary. If only want to upgrade for a one specific reason, then don't spend the money now.
- Jim he likes what's being offered, but he too is very concerned with the cost. Would like to see money being spent for a significant reason and not until the Sheriff's office and everyone else is on board.
- Don his main concern is public safety.
- Steve the cost should be incurred when we all can intergrade together.
- Brian we need a plan and make sure everyone is on the same page before we
 move forward with any expenses. The matter needs to be discussed more prior
 to making a final decision.

Rob suggests putting this issue off until March's meeting. He'll get together with the Sheriff and the county board to see about getting a plan together and see where everyone is before moving forward. A motion was made to table this issue until the March meeting by Brian and seconded by Jim. Motion passed.
